Tom thinks people would be most surprised to know the diversity of projects the NWCCOG works on in our communities. The work impacts so many communities with such far-reaching influence.



## Open Enrollment comes to a Close -Northwest Connect for Health Colorado HUB Report



The three-month Connect for Health Colorado Open Enrollment Period ended February 15, for 2015 health insurance coverage. We saw many successes and many challenges during this enrollment period.

Marketplace insurance enrollments rose in all nine of our counties (Eagle, Garfield, Grand, Jackson, Moffat, Pitkin, Rio Blanco, Routt, and Summit.) State-wide, all but one county had higher enrollments over 2014 enrollments. Our health coverage guides worked tirelessly to educate communities about health insurance and enrollment availability. Each Assistance Site was over-capacity to assist consumers.

While we consider our efforts to have been very successful, we recognize there are still concerns and frustrations as we continue to work through policy and

system issues.

Because there are still challenges to overcome, Connect for Health Colorado has

negotiated with insurance carriers to allow consumers who have started the 2015 insurance application process between November 15, 2014, to February 15, 2015, to enroll in an insurance plan outside of the open enrollment date. Also, there will be retroactive effective dates allowed for consumers who may need retroactive coverage.

Our Health Coverage Guides showed great patience, tenacity, problem-solving skills, and compassion for their consumers. Connect for Health Colorado is seeking feedback from all field staff. The HUBs are participating in the work flow designs and system enhancements to help to improve the systems and direction of Connect for Health Colorado.
