### Census 2010 vs. 2000, American Community Survey (ACS) Data for each NWCCOG Member Now Available on NWCCOG's Website

A sample of up-to-date Census data for each NWCCOG member jurisdiction is now available on NWCCOG's website. Both Eagle County and Summit Counties have populations large enough (over 25,000) such that 3-year ACS estimates (2008-10) are available. For the rest of NWCCOG's jurisdictions, ACS 5-year estimates (2006-10) are available.

What is the difference between Census 2010 data, and ACS data? ACS data represents the average characteristics of each county/town for the 5-year time span (or 3-year time span in the case of Eagle and Summit Counties). ACS data is best used for analyzing small populations, as this data is available for all geographies no matter how small, down to the block group. It is useful for comparisons of characteristics across geographies. For example, to compare the median household income in the Town of Silverthorne to the median household income in the Town of Gypsum. Total counts from ACS data will be different from Census 2010 data because ACS is a time span estimate, while Census 2010 is a point in time count.

Please note that the data available on NWCCOG's website is just a selection of the plethora of data that is available from the U.S. Census Bureau. One of the many services NWCCOG provides to its members is to serve as a clearing-house for demographic information. ### Forest Business Loan Fund Now Available to Forest Product Businesses

Financial lending assistance for businesses that harvest, remove, utilize or market timber from beetle-killed stands and other forested areas is now available through the Northwest Colorado Council of Governments - Northwest Loan Fund, and the Colorado State Forest Service. The program will provide community-based financial lending capital for timber and wood products businesses to expand their capacity to more economically remove, use, and develop new market opportunities, and help address employment concerns in forest based communities. Forest Business Loan Fund is currently limited to businesses in counties serviced by the Northwest Loan Fund. Funds will be available on a first come, first serve basis. There is not a closing date to apply, but applications are encouraged to be submitted by April 30, 2012 for timely consideration. Please contact June Walters for more information.
