Once pre-qualified, an intake form will be completed. A volunteer will then schedule a time to analyze the project and determine the materials needed. In most cases, the senior needing the work completed will be responsible for supplying the materials. If purchasing the materials creates a hardship, our team will look for alternatives which may increase the time it takes to get the job done. Once the materials have been purchased the project will be scheduled for completion.



How is the 'Helping Hands for Seniors Program' different from our normal 'Weatherization Program'?

- "Helping Hands for Seniors" program is only available for Seniors in Eagle County and is typically for smaller jobs that can be completed by volunteer "handy men/women."
- Our Weatherization Team works on much bigger jobs throughout the Region 12 area, as well as, in Chaffee, Clear Creek, Garfield, Lake, Moffat, Park, Rio Blanco, and Routt Counties.

- Our team weatherizes low and moderate income homes to reduce their fuel consumption and heating costs. Services include insulation, caulking, weather-stripping, installation of storm windows, new or repaired energy-efficient furnaces, and refrigerators.
- If you receive LEAP, TANF, OAP, SSI, SSDI, SNAP, or AND you automatically qualify for NWCCOG's Weatherization services. The improvements will be made by NWCCOG Weatherization Specialists through federal and state grant monies.
- We are still looking for Weatherization projects in Summit and Pitkin Counties -- if you know someone who may qualify for energy efficiency upgrades, please have them call Sherry at 1-800-332-3669.

Grand County Council on Aging Collaboration



This month we are celebrating the newest collaboration with the NWCCOG Mountain Ride Transportation Resource Call Center. The Grand County Council on Aging (GCCA) has recently contracted with RouteMatch software in order to coordinate with the Mountain Ride Call Center. RouteMatch is the same software used by Mountain Ride which makes sharing information easy.

The Grand County Council on Aging (GCCA) is thrilled to be aligned with the NWCCOG's Mountain Ride Program. Susan Hamilton, office assistant at GCCA, has worked

diligently under the guidance of Laurie Patterson and the RouteMatch support team to put in place software that will greatly improve efficiencies of scheduling, streamline client information, eliminate duplication of efforts and improve reporting data. "We're excited to move into an automated and much more efficient transportation management system over our current, very manual process" said Lisa Jonas, Executive Director at GCCA. Using the same software Mountain Ride uses enhances the ability to provide improved services.

Since 2014 the NWCCOG Mountain Ride Call Center has used RouteMatch Software to coordinate trips to medical appointments for veterans, senior citizens, low income, and people with disabilities in Summit, Grand. Routt, Jackson Garfield, Pitkin and Eagle Counties. This project is funded in part by Veterans Transportation and Community Living Initiative grant from the Colorado Department of Transportation.

Still looking for ways to incorporate Wellness into your workplace?



Consider this: The staff at NWCCOG has established a **Wellness Challenge for 2016**.

Here is how it works: Employees who wish to participate (most of them!) set a health/wellness goal for 2016. Wellness goals can focus on any aspect of health and wellness: physical, social, emotional, environmental, spiritual, intellectual, or occupational.

The employee then writes their goal down on a wellness challenge form (you can develop your

own - the goals need to be specific, measurable, achievable, realistic, and time-bound.) The employee fills out 2 copies. He or she puts each in an envelope with their own mailing address on it and SEALS up both envelopes. The envelopes are then placed in the "wellness challenge" box -- again, you can make up your own box.

Our wellness administrator then sends the 1st SEALED envelope one month into 2016 (by January 31st), and the second envelope 3 months into 2016 (by March 31st) as reminders to each employee to motivate them to work toward meeting their wellness goal.

Each employee who achieves his/her goal by end of June, receives a special prize... in the case of NWCCOG, they get an extra day off with pay! The challenge is completely optional, confidential, voluntary, and completely on the honor system. By setting the goal 6 months out, with two reminders, it's a great way to keep people motivated to succeed.

A little creativity can have your team motivated to incorporate wellness into their work and personal lives.

December 2015 Regional Economic Update

Some of you have already seen the results of the <u>December 2015 Regional Economic Update</u>, but if not, take a moment to review the stats for the region. It is a good news picture!

The December 2015 Regional Economic Update is now available on the EDD website here. This update is provided quarterly, and is based on the most recently released data from the Quarterly Census of Employment and Wages (QCEW), available through the Colorado Department of Labor and Employment (based on data released for 2nd guarter of 2015).

• 3-Year Job Growth: +7.1%

 Job Growth in Key Industries: Construction +10.8%; Accommodations & Food Service +2.3%; Agriculture +13.32%; Healthcare +3.0%

Real Estate Transactions: +17.8%

New Unit Sales: +190.9%
