Be Aware - Mandatory Reporting of Elder Abuse

A new state laws goes into effect July 1, 2014, **requiring** certain professionals (paid or unpaid) to report suspected abuse or exploitation of at-risk elders (age 70 and older) to law enforcement. The list of professionals is quite extensive and if you have questions, please contact your area representative for additional information.

Everyone continues to be urged to report abuse, caretaker neglect, exploitation, and self neglect of anyone age 18 or older

to their respective county Adult Protective Services.

The state Adult Protective Services staff want to be sure that county departments of human/social services are communicating with their local law enforcement agencies, District Attorney's offices, professionals, and other community stakeholders about the upcoming changes.

Information is available with your county's Adult Protective Services department. In some counties the county department of human/social services would consider scheduling a meeting to discuss the particulars of information-sharing on these cases, and the expected additional

referrals that will come from the mandatory report law going into effect.

Connect for Health Colorado- The Results Are In!

As reported last month the NWCCOG serves as the Regional Hub for the Colorado Health Benefit Exchange for northwest Colorado, and provides coordination services to 19 assistance sites throughout 9 counties including NWCCOG's 5 counties (Eagle, Grand, Jackson, Pitkin, and Summit) as well as Garfield, Routt, Rio Blanco, and Moffat.



The Connect for Health Colorado Marketplace saw a surge of enrollment in the marketplace in the final few days of open enrollment. The dust has cleared, the issues have been resolved and the tally is in. Our 9 county area had more than 7700 sign-ups for health care! We consider our efforts to have been a great success.

Our focus now turns to strengthening our advertising, community outreach, small business outreach, and training opportunities. We are in the beginning stages of creating a certification

process for Health Coverage Guide trainers, and creating more effective communication systems between the Assistance Sites and the centralized Customer Service Center. We continue to identify areas for improvement on the website as well as inter-departmental communication and training.

Breaking GOOD NEWS!!

The US Department of Health and Human Services approved a Colorado Division of Insurance request to redraw the 11 current geographic rating regions as 9 regions in 2015 -- thus potentially lowering the insurance rates in the resort areas in our Region. More info to follow.

Regional Transportation Coordinating Council- A New Look

Moving toward being able to provide regional transportation services throughout the 7 county area of northwest Colorado including Jackson, Routt, Grand, Summit, Eagle, Garfield, and Pitkin Counties, we are putting the pieces in place.

The One Call/One Click call center is being formed to assist in providing transportation for veterans, older adults, and ADA eligible individuals. Working with existing public and

private transit providers our goal is to facilitate seamless access to transportation for trips inside and outside our region. The call center will be able to track and bill for services in addition for arranging for transportation.

Mountain Ride was selected as the name of the program from a long list of suggestions submitted by stakeholders around the region -- here's our new logo. The website mtnride.org is currently under development and we'll let you know when it's open for business.

Safety Tips

Last month we talked about the importance of proper ergonomics associated with working at a desk. This month, our focus is on micro-breaks. In this day of hurry, hurry -- we often don't take the time to get up, stretch, relax our muscles and regenerate our energy with regular breaks. We just don't think we have the time.

But we all can take the time for micro-breaks. These frequent, short breaks can last for as little as 30 seconds to two minutes and can mean the difference between working efficiently and effectively -- or become tired and stressed.



Every once in a while, rest your eyes. Look away from your monitor, gently rub your eyes as shown, and change your view for just a few moments. This will help to prevent eye strain.



Think about standing up when you take a phone call. This gives you an opportunity to stretch your legs and lengthen your spine.



Sitting in one place for extended periods of time can cause the muscles in your neck to tighten -- often resulting in additional tightness in your shoulders and back. Take a few moments each hour to stretch your neck from side to side. You can also rotate your shoulders forward and back for additional muscle relaxation.



The Executive Stretch is one we practice daily -- clasp your hands behind your head and pull your elbows back -- this releases tension in your back and chest.

Frequent, gentle massage of your hands and forearms can relieve the stress of repetitive motion and can help fight the onset of carpel tunnel syndrome. Additionally, stretching your hands backward (shown) and forward can release tense muscles in your forearms.



These and other quick stretching exercises can ensure you work in a healthy and safe way each day. Take the time -- you'll be amazed!
