Steering Committee Meets on April 11th for a Planning Seminar to Kick-Off Regional Broadband Effort

The Department of Local Affairs (DOLA) has awarded a grant through the Energy and Mineral Impact Assistance Fund (EIAF) to NWCCOG for the development of an eight-county strategic plan to improve broadband capacity across the region. Through a competitive selection process, NWCCOG has selected Mid-State Consultants, Inc. as the technical consultant to prepare the plan and otherwise assist NWCCOG to fulfill the intent of its grant. The participating jurisdictions include Eagle, Grand, Jackson, Moffat, Pitkin, Rio Blanco, Routt and Summit counties plus the City of Glenwood Springs and the Town of Carbondale.

A steering committee made up of one representative from each of the eight participating counties will be guiding this strategic planning process. Steering committee members include IT directors, county commissioners, and a chamber of commerce executive director. The steering committee met on April 11th in Glenwood Springs for a planning seminar with Mid-State Consultants to kick off this project. During the planning seminar,

deliverable in detail to assure that all of the participants are in agreement that the expectations are clear and reasonable. The end result will be a regional plan and will specifically include recommended actions steps for the NWCCOG Council to consider as next steps in improving the broadband capacity for the region. Surveys and workshops during the summer months will be part of the data collection and education components of the project. Mid-State Consultants are now working to collect information for a regional asset map through existing data and interviews with vendors in the region. The goal is to present a draft strategic plan to the NWCCOG Council at the September 26th strategic planning session in Glenwood Springs. For more information, visit NWCCOG's website.

The NWCCOG Economic Development District (EDD) Working Group met on April 24th at the Eagle County Courthouse. This group serves as the guiding force behind the NWCCOG EDD Scope of Work. It is made up of NWCCOG member jurisdictions' staff, elected officials, representatives from chambers of commerce, business groups, Colorado Mountain College, Colorado Workforce Center, as well as our partners at the state including the Office of Economic Development and International Trade (OEDIT) and the Department of Local Affairs. The Alpine Area Agency on Aging's mini-grant program is again being offered in 2013. The amount of funding available is approximately \$6,676. The identified priority projects include Advocacy, Coordination, Emergency Service Delivery Situation, Equipment, Program Development, and Training & Professional Development. The mini-grant program is administered through the Regional Advisory Council, and is to support applicants or implementation located within Region 12 that includes Eagle, Grand, Jackson, Pitkin and Summit counties. Deadline to submit an application is May 31, 2013; awarded projects must be fully completed by June 30, 2013. Funding for the mini-grant program is provided through State Funds for Senior Services.
