# **Comprehensive Economic Development Strategy Update**



NWCCOG Economic Development District is updating its Comprehensive Economic Development Strategy (CEDS) this year. The CEDS is meant to be a tool for regional economic development decision making as well as a guide to understanding the regional economy so that we as a region are positioned to take action to improve it. Our CEDS is taking into account and, where appropriate, incorporating other regional planning efforts already under way in the region. Economic development planning - as implemented through the CEDS - is not only a cornerstone of the U.S. Economic

Development Administration's programs, but successfully serves as a means to engage community leaders, leverage the involvement of the private sector, and establish a strategic blueprint for regional collaboration.

The CEDS update process began in January with county-level meetings inviting a broad range of regional stakeholders (local governments, the business community, education providers, workforce groups, nonprofits, and other community groups) to conduct an analysis of the Strengths, Weaknesses, Opportunities, and Threats (SWOT) in each county and in the region as a whole.

From analysis of the SWOTs, as well as other planning efforts under way in the region, the following strategic priority areas have emerged:

- Workforce: need for affordable housing, health care, child care, transportation, and education
- Build capacity in our communities to have the community infrastructure necessary to attract human capital, support the business community, and support education; this includes broadband and access to capital, affordable housing, and health care
- Diversity in the economy: develop the entrepreneurial ecosystem and encourage the growth of new industries
- Create and maintain communities and a business climate attractive to entrepreneurs
- Need for higher-paying jobs
- Support our key industries and existing businesses
- Protect our community character and natural environment
- Build capacity of our towns and counties to meet their economic development goals

The next step will be to develop a draft regional action plan for the CEDS.

Over the past year, OEDIT hosted thirteen strategy sessions throughout the rural regions of Colorado to develop the ten different initiatives that communities would find most beneficial to

apply for through Blueprint 2.0. Each initiative includes services not previously provided by the state and leverages state resources and partnerships with organizations outside of Colorado to provide technical assistance to regions that expressed an interest in pursuing the initiatives. Many communities applied for Colorado Blueprint 2.0 initiatives, and during the application process, communities and regions were asked to demonstrate collaboration, strong local leadership, and solid support for the initiative they chose to pursue.

Initiatives will be deployed between now and December 2016. A new round of Blueprint 2.0 initiatives will be unveiled in 2017.
