### E-Bikes Public Process Project Roaring Fork & Colorado River Valley

#### Multi-Jurisdictional and Agency Team Launch Effort to Gather Public Opinion

**PITKIN/GARFIELD/EAGLE COUNTIES** – Pitkin County Open Space and Trails, in conjunction with the Roaring Fork Transportation Authority (RFTA), is asking for public input on the use of e-bikes on hard-surfaced (paved) bike paths from New Castle to Aspen. The public comment period is from March 19 – April 20, 2018. Input will be collected via <u>electronic</u> <u>surveys</u>, paper surveys and comment cards. This input will help shape a recommendation to the RFTA Board of Directors on whether and where to allow class 1 and 2 e-bikes.

Class 1 e-bikes provide electrical assistance only while the rider is pedaling. Electrical assistance stops when the bicycle reaches 20 mph. Class 2 e-bikes provide electrical assistance regardless of whether the rider is pedaling or not. Again, electrical assistance stops when the bicycles reaches 20 mph. Currently, class 1 and 2 e-bikes are only permitted on the Rio Grande Trail between Two Rivers Park in Glenwood Springs and the Emma Road intersection in Basalt.

"The goal of the project is centered around transparent public outreach with involvement from all affected jurisdictions to see if a consistent regulation on class 1 & 2 e-bike usage can be recommended to all jurisdictions," said Gary Tennenbaum, Director of Pitkin County Open Space and Trails. "All feedback will be gathered and presented to the local jurisdictions with a potential recommended regulation in May or June."
