



2	Just e-bikes. The Governor's e-bike law was going into effect on or about August 11 or 14, the RFTA Board needed to to pass a resolution to prohibit them or specify which class to allow. It voted to allow class 1 and 2 e-bikes.	4/3/2018 11:51 AM
3	Our town council was interested in allowing e-bikes on paved recreation trails when it was not allowed by state law. We did a pilot program by ordinance starting in 2016 and found no significant issues to date. 4	Our City Recreation Director sits on the County "Trail Mix" group. They have been struggling with keeping ebikes off non-motorized trails in the County. 





## Q10 Do you have regional trails where e-bike regulation does or would involve multiple jurisdictions?






