Call to Order:

Alyssa Shenk called the Northwest Loan Fund (NLF) Board meeting to order at 10:02a.m. Round table introductions were conducted, and a quorum was present.

Approval of August 2021 NLF Board Meeting Minutes:

M/S: Thomas Fridstein/Carolyn Skowyra to approve the August 2021 NLF Board Meeting Minutes as presented.

NLF 2021 Preliminary End of Year Financials:

Anita clarified that the 2021 COVID loans will show up on balance sheet including COVID Funding CBDG loan 2630. The income statement COVID funding is still low as the funds have not yet been received. *M/S: Patty McKenny/Jeanne McQueeney* to approve the NLF 2021 preliminary end of the year financials as presented.

Verbal Review of 2021 Activity and Q&A, Anita Cameron

- In 2021 NLF approved \$1,467,000 in loans which do not show on the Profit and Loss statement as they have not yet been reimbursed. \$150k of these loans have not yet closed. Additional funds of over \$500k have been approved and reimbursements requests have been made. As funds are received, they will show up on the Profit and Loss statement. The COVID funds are not required to create jobs and therefore have been used first.
- Three Energize loans of \$20k each at 1.4% interest have been made however business have not been as interested; several rounds of request for applications were sent out. Per the contract, \$113k was returned to the State of Colorado.
- Scott left as an employee in October however he is now a contractor as a Financial Analysis
 which is working great. Posting of payments has been handed off to Becky Walter as a
 contractor to NLF.
- Inquiries for 2022 are very strong.

NLF Update: NLF Reports

Anita explained the NLF Memo to Board regarding the Loan Risk Ratings which proposes two new risk ratings due to a loan secured with a commercial property. These two new categories will better identify the possible losses.

NLF Update: Energize Colorado Loan Fund

The State has added 3.5 million for start-up loans which Region 9 has agreed to manage. Due to high insurance requirements, the loan is currently cost prohibited. Region 9 is attempting to negotiate these requirements with the State.

Call to Order

Alyssa Shenk, NWCCOG Council Chair, called the Northwest Colorado Council of Governments (NWCCOG) and Northwest Loan Fund joint meeting to order at 10:00 am.

2021 Audit

Jon introduced Sam Hellwege with CLA. The NWCCOG Council delegated approval of the 2021 Final Audit to the NWCCOG Officers. Patti Clapper was unable to attend and agreed to delegate all authority to Alyssa Shenk and Carolyn Skowyra.

Sam reviewed the Independent Auditors' Report, the 2021 Standards has made a small change to the formatting requirements but does not have an impact on the financials. The Opinion is now listed first on the report; The Financial Highlights offer a quick synopsis of the year's financials; the Financial Statements provide an all-encompassing view of NWCCOG financials; the Note section spells out more details about the entity. The two compliance reports are Internal Control Report where any material finding, or significant deficiency is spelled out; the Compliance for Major Federal Program Report which audits expenditures of \$750K or more.

- NWCCOG received a "Clean Opinion" for all financial respects in 2021.
- 2021-001: The only significant deficiency found during audit was regarding an NLF loan from CHFA that was reported incorrectly on the financials. The funds were correctly adjusted from Liabilities to Other Financing Resources. The funds were not misused.
- 2021-002: A Weatherization employee pay raise was not correctly coded and the employee and grant were undercharged for a total of \$20.67, which was correct.
- Accounted no significant difficulties working with management.
- No significant corrected mis-statements other than the NLF loan adjustment and Weatherization pay.
- GASB Statement No. 87, Leases NWCCOG has two leases which are now considered "right to use" lease and need to be coded under Lease Liability.

There were no questions or concerns.

Alyssa provided highlights from the Executive Director Performance Review which included how Jon is a great asset to the organization, he represents well- taking lead on important issues and does an excellent job at addressing community needs, Jon is skilled as an external communicator and brought forth great reports and workbooks. The Executive Committee is grateful to have Jon as the head of NWCCOG. Feedback from Directors show that he provides great support for all NWCCOG programs.

Approval of proposed 2023 Budget

Jon discussed highlights from the 2023 Budget Memo created from the October Budget Workshop:

- Adjusted the EIP revenue sending \$87k to reserves
- IT security had additional expenses
- Note: 45% of ED wages are from indirect opposed to member dues
- Closed on the FirstBank loan for the Gypsum warehouse on November 8th putting the funds back into NWCCOG reserves
- Tracking Energy Department inventory will be pulled from reserves and paid back by the department
- We did not receive the DOLA grant for Insight, that was pulled from the budget
- Requesting funds for Elected Officials Training and Mental Health Project
- Northwest Loan Fund projections were increased, \$400k will be shown in next years revised budget
- Wage range was bumped up 5.5% this year

Patti Clapper had a question regarding the Mental Health Project, Alyssa confirmed that approving the budget with the project funds is not the same as approving the project as is. There was a discussion on how the COLA percentage was determined and Jon confirmed that it was compared to the Denver COLA which was recommended at the Budget Workshop in October.

- 1.The DOLA Portal has errors in the NLF numbers and I cannot submit requests for Reimbursement until DOLA has this corrected (requested correction in September 2022 and regularly since)
- 2. On September 8, Eagle County requested additional Covid (CV) Funds. It took 2 months to get a quorum for an FRC (Federal Review Committee) Meeting. On November 7, \$812k* was approved. Now, we wait for signatures to fully execute the Amendment to the Open/Active CDBG Contract. The last amendment took 6 months for signatures.

Approval of proposed 2023 Budget

Jon discussed highlights from the 2023 Budget Memo created from the October Budget Workshop:

- Adjusted the EIP revenue sending \$87k to reserves
- IT security had additional expenses
- Note: 45% of ED wages are from indirect opposed to member dues
- Closed on the FirstBank loan for the Gypsum warehouse on November 8th putting the funds back into NWCCOG reserves
- Tracking Energy Department inventory will be pulled from reserves and paid back by the department
- We did not receive the DOLA grant for Insight, that was pulled from the budget
- Requesting funds for Elected Officials Training and Mental Health Project
- Northwest Loan Fund projections were increased, \$400k will be shown in next years revised budget
- Wage range was bumped up 5.5% this year

Patti Clapper had a question regarding the Mental Health Project, Alyssa confirmed that approving the budget with the project funds is not the same as approving the project as is. There was a discussion on how the COLA percentage was determined and Jon confirmed that it was compared to the Denver COLA which was recommended at the Budget Workshop in October.

Elected Officials Training and Mental Health Project

Jon recently presented the Elected Officials Training Workbook and proposed providing a retreat combined with the Mental Health Project created by Skippy Mesirow. Per Skippy, 81% of elected officials have experienced some type of threat with little training offered on how to handle these challenging moments. Skippy and Jon started brainstorming how to create a meaningful retreat unlike any other. CMC provides similar training that includes the nuts and bolts however it doesn't include the necessary details for elected officials or mental health training. Skippy partnered with Jamie Butemeyer, who has been through ICM training, to create the Elected Official Mental Health Project. The \$20k funding request from NWCCOG would cover the cost for two separate retreats: location reservation, food, hotel, and the service. It was clarified that Skippy and Jamie's Mental Health Project is a "for-profit" business; the cost per participant would be \$750.

There was a discussion on level of interest from members; many confirmed that they find this enriching, valuable and more modern than other training provided. Most jurisdictions will require an internal discussion regarding participation interest for new elected officials. It was confirmed that training may be appropriate for some key staff positions as well as elected officials however best practice would be to keep staff and elected official training separate unless training is organization specific.

It was agreed to leave the funds in the budget and aim for a training date later in 2023; providing members time to take this information to their jurisdiction and provide feedback at the March Council meeting. It was requested that a packet be sent out to members that included Skippy's website as well as testimonials from those who have already participated. Skippy will provide free one-on-one meetings to anyone interested provided the following link which includes testimonials: https://www.electedleaderscollective.com/home#Testimonials.

I would like to welcome our new Regional Grants Navigator to NWCCOG's, Jonathan Godes. This is a new position that will develop a thorough understanding of the grant funding opportunities in the Federal Infrastructure Investment and Jobs Act, as well as the Inflation Reduction Act, and assist our 32 member organizations across 6 counties to connect to funding opportunities from these acts. The State of Colorado through the Governor's office and Office of Economic Development and International Trade (OEDIT) has allocated funds through Senate Bill 22-15 to fund the regional grants navigator position and a cohort of parallel positions at each of the regions represented by Councils of Government across the state. Jonathan will collaborate with OEDIT and his peers across the state to help interested NWCCOG members understand what opportunities they may qualify for, and how and when to apply for those grant opportunities.

Jonathan has lived and worked in the mountain communities of the Western Slope building relationships, fostering collaborations, and working in, and with, local governments and the nonprofit community for the last 20 years. He founded the Boys & Girls Club of Craig and served as its Executive Director before moving to Glenwood Springs to work for the City of Aspen. He started and directed the nonprofit Early Childhood Network for seven years prior to his most recent work in private business finance. He was elected to the Glenwood Springs City Council in 2017 and has served as the mayor since 2019.

Jonathan is a strong believer in regionalism and is a long-serving board member of the largest rural transit system in the country (Roaring Fork Transportation Authority) and is the current board president of CAST (Colorado Association of Ski Towns). He is a federal appointee to the Small Community Advisory Subcommittee of the EPA, and has testified many times at the state legislature on issues impacting mountain communities. His recent areas of work have been in housing affordability, infrastructure resiliency, and ensuring that rural communities are not overlooked. AABC Integrated Clean Energy Micro-Grid

Executive Summary:

With the ever-rising threat of Climate Change, actions need to be taken to mitigate contributions through the emissions of greenhouse gases and to adapt critical infrastructure to create resilient communities in the face of the already seen increase of catastrophic events. The implementation of micro-grid systems at vital public facilities is an action that does just this.

The AABC Integrated Clean Energy Project is an innovative implementation of the tried technology of micro-grids by integrating the key facilities of three distinct public entities: Holy Cross Energy (HCE), the Roaring Fork Transportation Authority (RFTA), and Pitkin County (which also oversees the Aspen/Pitkin County Airport). These facilities provide for regional transportation, the upkeep and maintenance of the community, staging points for emergency services, and the backbone of the regional electric grid. The completion of this project has the potential to take all the facilities to net-zero emissions by allowing optimized load distribution of renewable energy, provide a distribution point to the surrounding community for stored renewable energy, and significantly improve the resiliency of the regional grid and of the facilities themselves during catastrophic events. Furthermore, through the creation of an administrative and ownership structure, this project can serve as an example for replication in any community with more than one public entity providing public services.

To implement this project, four key components are required. The first is the installation of energy storage in the form of Mega-Watt (MW) scale batteries. These installations must be paired with load management software and once installed can be expanded in a modular fashion to meet any future growth of the system. The second is the installation of new, and integration of existing, renewable energy generation into the system to provide the generation aspect of the micro-grid. This allows for operations to continue when the regional grid goes down and for the optimal use of existing renewable energy being generated in the community. The third is the creation of an administrative and ownership framework for the micro-grid and its sub-components. With three distinct public entities involved, each with its own objectives and needs, it is essential that mutually agreed upon structure for use and maintenance of the system is in place. The final component is the optimization of energy efficiency in the interconnected facilities. To minimize required load, allow for peak performance of the micro-grid, and permit such a system to have broader community benefit, energy efficiency measures such as heating districts and full electrification will need to be pursued.

To achieve all four of these components, cooperation among the involved partners will be required within their own areas of expertise. Holy Cross Energy, with its engineering expertise and direct oversight of the regional grid, is best positioned to provide system design, load management, and a tariff system for micro-grid discharge into the regional grid. RFTA is best able to provide renewable energy generation, site location for energy storage, and provide emissions free regional transportation. Lastly, Pitkin County serves as the driver of the project, providing project management, site locations for energy storage, and serves as the arbiter of the administrative structure.

With each partner doing their role, and with a steadfast desire to mitigate and adapt to Climate Change, the pursuit and implementation of this project has the potential to provide for a more resilient community and a pathway for a regionally net-zero economy.

Notes from 2022 Housing Colorado Summer Engagement meetings:

Greetings in this New Year!

These interactions have shaped the way in which policies have been written and rolled out as well as our perspective as we head into the 2023 legislative session.

Our state is uniquely positioned to address the affordability crisis we face. With new and existing resources ready to be allocated, we are confident that we can make headway in building and preserving housing that is affordable to all Coloradans, especially those who are most vulnerable.

Thank you for your participation in our Statewide Engagement and Outreach sessions last year. We look forward to maintaining our connections with you in the near future and beyond.

Housing Policy Debrief: Housing Colorado discussion

At every stop during our Statewide Engagement and Outreach tour, we led an open forum conversation that allowed participants to bring up ideas, issues, and insights from their experience working on the ground. We endeavored to capture those comments and will summarize what we heard below. Please note that this synopsis does not encapsulate everything that was brought up during these sections of the programming, but instead tries to draw out major themes that we heard across the six engagement sessions across the state.

Theme 1: Collaboration

Working together across sectors and regions was a major theme that emerged through all the tour stops. Participants were happy to be in the same room with others in the affordable housing world and found that there were a number of ways that they could be working together. There was a hope throughout the events that opportunities to connect and collaborate could continue. With individuals on the ground from each of the three organizations represented, there is a commitment to continue to foster connection and collaboration beyond once-off Statewide Engagement and Outreach events.

Theme 2: Tenant Rights, Protections, and Empowerment

A number of ideas and questions came up that related to tenant rights, protections, and empowerment. This area of conversation included topic such as:

- The need to eliminate onerous screening criteria by landlords that is circumventing source of income discrimination protections already afforded to renters by law.
- Educating tenants about the rights they already have and the outlets for enforcement of those protections should violations occur.
- Efforts to organize and mobilize mobile home park residents to 1) ensure that conditions in parks meet public health and safety standards and 2) ensure that residents know their rights and what resources might be available if their park goes up for sale.
- Regulating rental costs and increases.

Theme 3: Understanding the Unique Needs of Various Communities

In the context of DOH working to categorize counties according to the stipulations of HB22-1304 and SB22-159, the need to more deeply understand the unique characteristics and needs of local communities came up time and time again. The unique challenges facing urban, rural, and rural resort communities are different, and participants implored resourcing and legislating entities to consider those differences when trying to make decisions about funding needs. One size fits all solutions to our affordability crisis in Colorado will not work so it will be important to listen to local communities and respond accordingly.

Theme 4: New Funding

Between one-time federal dollars and the now-passed Proposition 123, hundreds of millions of dollars in new funding for affordable housing is in the pipeline. There were discussions about

how that money will be distributed and equity concerns were shared by participants. In addition, concern was expressed in general about how small local governments and small nonprofits can come to learn about and access resources as they become available.

Other Items of Discussion

A number of items that didn't fit neatly into the themes shared above were brought up during the outreach events. They are captured here in list form with as much context as possible:

- The need for neighborhood-scale interventions to address gentrification and displacement.
- Changing current Colorado statute prohibiting rent control to allow for caps to rent increases.
- The need for technical assistance and capacity building for smaller communities to access available resources at the state level.
- Homeless Management Information System
 - Reporting and capacity
 - Rural set aside?
- Address the construction defect law to open up possibilities for households to move from rent to homeownership.
- Address the effects that short term rentals have had on the housing market, especially in resort communities.
- Working to develop resources to address objections to affordable housing development.
- Create incentives for employers to build housing for workers.

Table Topic One: AFFORDABLE HOUSING TOOLKIT FOR LOCAL OFFICIALS

As part of HB21-1271, DOH was tasked with the creation of a toolkit for local governments and elected officials, which would include educational and training opportunities focused around policies that incentivize affordable housing as well as a competitive application for tailored technical assistance for communities struggling with affordable housing. On July 1st, Enterprise Community Partners was selected as the consultant to work with DOH on the creation of this toolkit. The timing worked out so that DOH and Enterprise could take advantage of the outreach events around the state. Having so many housing experts in the same room made for the perfect opportunity for DOH to ask for input from folks from different regions as to what they would like to see from the Affordable Housing Toolkit for Local Officials. There were many themes common to different regions, such as:

- Outdated zoning codes and overburdened planning departments can be a barrier to affordable housing. A lack of funding and capacity can present challenges to updating those codes and addressing the lack of affordable housing.
- The idea of regional housing consortiums, whether made up of smaller Front Range communities, rural agricultural communities, or mountain resort communities, to tackle similar affordable housing issues in collaboration.
- Participants provided examples of how the tailored technical assistance could be used in their respective communities, such as planning for attracting developers to more remote communities, the creation of discretionary housing funds, and revising zoning codes to be more conducive to the creation of affordable housing.

DOH and Enterprise were able to use the feedback received to craft the curriculum for an Affordable Housing Toolkit for Local Officials that will respond to the unique issues present in the different market types and regions around the state.

EMERGENCY RENTAL ASSISTANCE

In each outreach session stakeholders met with DOH, CHFA and Housing Colorado staff to discuss and provide feedback about the Emergency Rental Assistance Program (ERAP). Stakeholders were prompted with three questions. (Below is a summary of the discussion on each topic.)

- Has ERAP supported clients of your organization? How impactful has ERAP been to your organization?
 - The ERA Program has been indispensable to communities throughout Colorado in a time of great need
 - The ERA Program prevented thousands of household from eviction during the pandemic
 - Great need for a long-term rental assistance program
 - Legal aid paired with rental assistance is most impactful
 - Need for more wrap-around services to ensure long-term stability
- 2. After ERAP funds run out, what local community resources do you have for eviction prevention?
 - Few local rent resources. Of the local resources, none will compare to ERAP
 - Some communities have limited Community Service Block Grant (CSBG) funding for rental assistance after ERA funding is exhausted

- Concerns that community resources will return to pre-pandemic levels, where most households in need were not able to access them
- Community resource centers bracing for need after ERA funds are exhausted, but fear they will not be able to keep up with the demand
- Cliff-effect concerns post-ERA without eviction moratoriums in place
- 3. If you could design your ideal eviction prevention program, what would that look like? How many months of assistance? Eligibility criteria? Other supportive services? This question prompted good discussion and feedback. Common themes included:
 - Income eligibility
 - A combination of legal defense paired with rental assistance
 - Limited rental assistance to ensure the most reach throughout Colorado
 - o 3-6 months of assistance
 - Sliding scale, based on income
 - O Tapered assistance to support self-sufficiency (e.g. month 1 assisted at 100%, month 2 assisted at 75%, month 3 assisted at 50%, etc.)
 - One-time assistance every few years
 - Requirement of a substantial life event that caused the need for the assistance
 - Requirement of sustainability of the home in the future
 - Required legal representation for all tenants facing eviction
 - Adding additional review agencies throughout the state to ensure adequate community representation
 - In-person application access
 - Wrap-around case management
 - Appropriate marketing of the program to ensure all Coloradoans know of the program
 - Landlord training
 - Current tenant-landlord laws (source of income, late fees, habitability, discrimination, rent increases, illegal evictions)

HOMELESSNESS RESPONSE

Stakeholders were prompted with three questions:

- 1. How would you grade your regional homeless response system?
- 2. What do you see as the most effective means of supporting or incentivising collaborative action on homelessness?

3. How does racial equity inform the design of your community's homeless response system? (or should it)

Many of the table discussions went beyond answering these specific questions and more to homelessness response in general or questions/input regarding the new funding opportunities from the new bills. The following are the main themes/trends shared:

- Some rural/frontier areas of the state, such as Jackson County, have little to no homelessness response system, including no main providers or housing resources. Many do not know their homeless and housing needs, but Built for Zero (BfZ) is helping many with that and want to continue that. These communities want to expand what little they have; while others need help knowing even how to start and how to get local support.
- Resort communities have unique needs with seasonal workers, short term rentals, and higher AMIs still not livable.
- Any new homelessness response funding needs to include funding for supportive services and operating costs for any homeless and housing program across the homelessness response continuum [i.e. - outreach, shelter, prevention, Rapid Rehousing (RRH), and Permanent Supportive Housing (PSH)].
- Need to build capacity for staff to engage, know, coordinate with other community resources/partners. Need to build capacity for applying for and administering gov't funding. Need capacity to coordinate across partners, communities, systems and reduce siloed and competitive localities/organizations.
- With that said, several communities did give examples of increased efforts in outreach, collaboration, data, increasing homelessness response systems, and look to new funding to help continue that work, not have to start over or have funding conflict with recent efforts.
- Hidden populations, particularly hidden Latinx, Native Americans, undocumented immigrants. Need to build trust, Spanish speaking, cultural competency, peers, more outreach.
- Cost of living in addition to the cost of housing is high, so rental assistance is not enough.
- Short to medium term assistance has limited effectiveness because more permanent housing options to transition to. Need more vouchers in general. Need more landlords and units willing to take vouchers. Need more single site supportive housing.
- Some feedback included not focusing on PSH or currently homelessness and instead focus on more upstream efforts to prevent inflow.
- Many attendees had questions regarding the application processes that will be coming.
 Main focus was on flexibility for the funding and simplicity of the application process.

- HMIS forms can be challenging to have individuals complete and is often not the only database/platform used by agencies so interoperability would be helpful.
- Accessible units and helping people get access to the housing was identified as a need.
- Multiple application dates and a variety of activities for a comprehensive project concept would be helpful.
- Many noted the challenges with landlords being able to ask for more money, having concerns about damages/behavior/etc.
- Staffing capacity in general is a stress for many organizations as staffing vacancies have increased while the need seems to as well.
- Some suggestions: Single-site PSH makes a difference for one provider's veteran participants. Trauma-informed care training should be provided to everyone.
- Is there a way to use work from HUD NOFOs for DOH NOFA applications so COCs and communities who worked on those feel they can use those efforts and stay consistent with those efforts.
- Several noted the importance of incorporating peers, lived experience, and participant input.
- Several immediate needs/challenges, such as encampments or shelters closing, were on top of mind for many stakeholders, making it challenging to focus on more macro system change with urgent issues needing immediate attention. Hard to focus on systems coordination and long term change with these current challenges.
- Some expressed that more basic needs assistance such as hygiene resources, shelter, or other capacity to manage homelessness would enable communities to focus on solving homelessness.
- Request flexibility on who is defined as homeless.

LOCALITY CLASSIFICATIONS

Stakeholders were asked the following questions:

- 1. What information about unique housing and economic circumstances should be considered in order to determine whether a locality is classified as urban, rural, or rural resort?
- 2. If a locality seeks to be reclassified, what information about unique housing and economic circumstances, if any, could the appellant be expected to submit to the Division of Housing?

3. What should be considered in terms of how the locality reclassification process is operationalized? For example: how can expediency be balanced with diligence, or flexibility balanced with structure?

The novelty of this policy and process resulted in lively and productive discussion, including:

- Administrative responsiveness
 - O Housing, labor, and other markets change frequently, but the information used to measure economic needs and design affordable housing policy responses is often stale or imprecise. Accurate and timely information that most appropriately illustrates local needs should be used for policy development to allow for responsiveness to local needs.
 - O The process through which the Division of Housing reviews and makes determinations on locality classifications should be intuitive and involve technical assistance, so that policies can be updated to meet the needs of localities, without placing stress on the capacity of localities.
- Policymaking flexibility
 - O The method through which counties were initially classified, based upon the work of the Strategic Housing Working Group, was seen as an important starting point as it creates the conceptual framework through which all localities will be considered. However, participants shared that the policy may have to be changed for their localities in the future. Often because the challenges and needs of their municipality differ from those of their county. Or, because the unique conditions of their area were outside of the scope of the Strategic Housing Working Group.
 - O Participants shared that this new policy and process would be a learning and growth experience on all sides, and generally agreed that open communication and close collaboration between DOH and customers would improve the effectiveness and efficiency of this shared responsibility.

REVOLVING LOAN FUND & MOBILE HOME PARK ACQUISITION

Stakeholders were prompted with two questions:

1. What types of loans are of greatest need and what flexible loan terms are of most importance?

- Acquisition, bridge and long term financing all needed.
- High LTV (consider lending over appraised value but up to 100% of cost in areas where it is more expensive to construct than the appraised value of the new property)
- Low rates and/or flexible (interest only, extended amort & cash flow based) repayment terms.
- Loan guarantees and/or cash collateral support
- Extended maturity dates to match senior debt
- Quick turn around in the Division of Housing underwriting and contracting process. Speed to market.
- 2. When seeking to purchase a Mobile Home Park (MHP) what are the most important technical assistance (TA) needs of your community and in addition to the need for acquisition loans what other capital improvements are in need of financing for MHPs?
 - TA is needed up front to help residents organize and take advantage of their right to purchase. Need to act quickly here!
 - Communication and TA needs to be in multiple languages to meet the needs of the community.
 - Post acquisition / long term TA will be a continuing need to help residents manage their Resident Co-Op and operate the MHP long term.
 - There is a need for nonprofits to step in when needed to purchase the park on behalf of the residents to ensure long term viability and property ownership/management expertise.
 - Need for individual unit repair and energy efficiency upgrade loans or grants.
 - Need for lot rent assistance grants to homeowners to prevent displacement.



 Does the initial classification of your community (and if it is Rural, Rural Resort, or Urban) reflect the housing market and economic factors present in your community?


- 2. How should applications for funding be made available? (1 of 2, before the programs were discussed by DOH staff)


Does the initial classification of your community (and if it is Rural, Rural Resort, or Urban) reflect the housing market and economic factors present in your community?

TINY HOMES, MOBILE HOME PARKS & ENERGY CODES

DOH staff met with interested stakeholders across the state to solicit feedback in response to three bills from the 2022 session that DOH's Office of Regulatory Oversight is tasked with implementing or assisting another agency in its implementation. The three bills are as follows:

- 1. House Bill 22-1242 Colorado law regulates the manufacturers, sellers, and installers of manufactured homes; on and after July 1, 2023, it will also include "tiny homes" as defined in the bill.
- 2. House Bill 22-1287 Effective October 1, 2022, the "Mobile Home Park Act" and its "Dispute Resolution and Enforcement Program" were amended to add additional protections for mobile home park residents.
- 3. House Bill 22-1362 On or before October 1, 2022, a "Energy Code Board" must be appointed and convened to develop both a model electric ready and solar ready code, and a model low energy and carbon code for adoption by counties, municipalities, and state agencies by deadlines established in the bill.

Participants in discussions concerning these bills provided some excellent insight and feedback. Overarching it is clear that more efforts need to be made in order to communicate these new requirements as well as any additional implementation efforts to local jurisdictions or mobile home parks and their residents to ensure they understand what is expected by the General Assembly in order to help DOH more effectively carry out these expectations. They also shared some specific questions or suggestions for consideration.

• HB 22-1242

- Accounting for community living; allowing for the bathroom/kitchen to be separate in a communal area to limit costs, i.e. tap fees
- O Distinguishing a home owner building their own from a manufacturer producing several units
- O Determining what is acceptable coming in from other states or units being highly mobile in the state
- Regulate by use to determine level of certification
- Create a program for communities to utilize to help with homelessness, including a training program to develop skills to construct them
- O Make sure standards are not so strict where it makes the product unaffordable
- Talk to the local communities about what they would like to see established for standards

- Need to clearly identify differences in types of homes and how they are regulated
- Making sure more units are accessible for individuals with disabilities; universal design/trauma informed design
- Allow for flexibility and evolution (ex. shipping container homes)
- Possibility of having 10 pre-approved designs or some sort of pre-approval checklist to fasttrack getting houses for people who need them
- Concerns that local jurisdiction zoning requirements preventing placement of tiny homes certified by the state

HB 22-1287

- O Clarify triggering event for notice of a change of use of the land
- Create a local government toolkit about mobile home parks
- Address concerns regarding parks requiring residents to provide verification of income, proof of title, or other information each year when the park is registering with the state
- Pausing the clock (tolling) on the timelines established in the opportunity to purchase the park provisions; concern with litigation and dragging these deals out and preventing them from closing
- Aligning with technical assistance funds made available for mobile home park residents as identified in Senate Bill 22-160 to help with meeting the opportunity to purchase provisions of this bill
- O Dealing with mobile homes in parks that are no longer habitable or close to being so and creating funding to help rehabilitate or replace them

O Account for lifetime cost; do not rely on upfront cost

PROGRAM UPDATES

The following are events of note occurring since the August 2022 NWCCOG Council meeting.

<u>Administration/Regional Business</u> – *Jon Stavney, Executive Director* Update to be provided during meeting.

Economic Development District (EDD) – Rachel Lunney, Director Program

EDA Planning Partnership Grant –NWCCOG has been invited to apply for the next three-year EDA Planning Partnership Grant. The grant amount is \$70,000/year, for three years, for a total grant of \$210,000. The main purpose of this grant is for overall administration costs for the district as well as developing, maintaining, and implementing the region's Comprehensive Economic Development Strategy (CEDS). This grant is matched 1:1 with NWCCOG member dues. EDD director is working on the grant which will be submitted to the EDA by January 31, 2023.

Data & Research – the December 2022 regional quarterly economic update is available on the EDD website here: https://nwccog.org/edd/data-center/economic-data/economic-data-by-county/. Staff will continue to develop and distribute bi-monthly EDD resources bulletins which provides information on funding sources including grant opportunities, access to capital for businesses, technical assistance, and training/professional development opportunities of interest to all stakeholders in the region including elected officials, town/county staff, non-profits, education, workforce, chambers, and businesses; these bulletins are archived on the EDD website here: https://nwccog.org/edd/business-resources/resource-bulletins/

Workforce Housing Report – work continues on the 2023 update to the Regional Workforce Housing Report. This is an update to the report completed and distributed January 2019. The report will include new programs, policies, initiatives, funding mechanisms, and programs that have been developed since the 2019 report, as well as 1-page summaries from towns and counties in the NWCCOG and CAST region. The report is planned for a June 30, 2023 completion date.

<u>Elevator Inspection Program (EIP)</u> – *David Harris* – *Director* Update to be provided in an upcoming packet.

<u>Energy Program</u> – *Nate Speerstra, Manager* Update to be provided in an upcoming packet.

<u>Northwest All Hazards Emergency Management Region (NWAHEMR)</u> – *Deborah Bogan, Coordinator* Update to be provided in an upcoming packet.

<u>Northwest Loan Fund (NLF)</u> – *Anita Cameron, Director* Provided during NLF Board Meeting

<u>Northwest Region Healthcare Coalition (NWRHCC)</u> – *Carmen Flores, Readiness and Response Coordinator* Update to be provided in an upcoming packet.

<u>Regional Transportation Coordinating Council (RTCC)</u> – Charles McCarthy Mobility Manager Update to be provided in an upcoming packet.

<u>Water Quality & Quantity Committee (QQ)</u> – *Torie Jarvis, Director and* <u>Watershed Services & Summit Water Quality</u> Committee (SWQC) –

Torie provides summaries after each QQ meeting. If you don't receive these but would like to, let Talai or Torie know so they can add you to the list.

Broadband Program – Nate Walowitz, Regional Broadband Coordinator

Nate Walowitz's local broadband efforts continue in communities across the NWCCOG region as well as statewide on behalf of DOLA to provide technical assistance in support of local broadband efforts.

We saw network traffic on the Project THOR network increase by 50% over the winter holidays. This can be attributed to both visitor and resident broadband usage during this period. This is first year that we have seen this significant an uptick in traffic over the holidays. I believe we can expect to see this trend increase in the future as dependence on broadband continues to grow.

Community meetings of note:

Roaring Fork Broadband fiber project (Pitkin County) meetings and conversations with Holy Cross Energy to finalize fiber lease from Glenwood Springs to Aspen to support communities along the fiber path including Basalt, Snowmass Village, community anchor institutions, schools and City of Aspen.

Town of Eagle consulting on new Meet Me Center at public works. Assisting to bring in additional broadband providers and get them affordable connectivity.

Work with Red Cliff to discuss improved broadband, WiFi and fiber broadband service projects through Vero, who purchased their ISP, ForeThought.

Conversations with Eagle County about improving broadband in Dotsero and working with HR Green, their broadband consultant, about both area information, potential providers, and Project THOR availability. Conversation extended to discussions with ISPs who reached out to NWCCOG to inquire about the availability of Project THOR in Dotsero.

Work with Grand and other foothills counties and towns providing Broadband technical assistance for the DOLA Resilience and Recovery Project.

Clear Creek County meetings about their numerous fiber to the premise projects and support for wireless broadband in Idaho Springs, Georgetown, Evergreen, and St Mary's. This work includes program review, fiber, broadband services and wireless tower leasing advisory.

Finalizing IRU agreement between NWCCOG and Holy Cross Energy to support the Roaring Fork Broadband Fiber Project. The participating local governments needed NWCCOG to act as a coordination point for management and operation of this regional fiber project. The fiber project will serve communities between Glenwood Springs and Aspen and Snowmass Village. This project is awaiting final fiber work to complete final connectivity.

Outreach activities include ISPs who have expressed interest in Project THOR and coordination with local communities to access Project THOR to deliver Denver transport resilience and competitive pricing with Lumen.

Other Meetings:

Meetings with small ISPs in our region and making plans to come to our region to deliver affordable, reliable fiber to the premise broadband service.

Continued support of Grand County, Gilpin County, Boulder County, Larimer County, Estes Park, City of Trinidad, Jefferson County, Jefferson County Public Schools. These meetings were all conducted as part of the statewide DOLA technical advisory services.

Work with the Colorado Broadband Office interviewing and orienting some of their key new hire employees, advising on local efforts, regional needs, and implementation strategies.

The Colorado Broadband Office has issued their 5 year Broadband Roadmap. This provides details on strategies they have developed to achieve their goal of deploying broadband to 99% of Colorado households.

Conversations with Estes Park's ISP, Trailblazer, related to backing up their front range transport connections to Denver leveraging Project THOR with reciprocal benefits to Project THOR through their network. March - October 2023 their forward connection will be down for replacement, so their connection to Project THOR will be pressed into service as needed.

Project THOR

DOLA Grant - NWCCOG continues to leverage our no-match DOLA grant, signing the first of 3 purchase orders for new network equipment with Ekinops. When complete, this equipment will replace our existing Ciena equipment resulting in a significant expansion of network capabilities by 200%, greater reliability, US based 24x7 support for 40% lower cost, and no need to replace equipment for 10 years. The CDOT (7 year) and Zayo (10 year) IRUs that were needed are now fully executed. This lowers costs to our network participants. The new network equipment will be delivered and installed in April 2023.

In July, Glenwood Springs chose to withdraw from Project THOR. This will be effective January 1, 2023. Because the City is currently hosting our equipment, we will need to move the network equipment to another location. We are working with CDOT, CO Department of Homeland Security, Holy Cross Energy and Pitkin County, develop and

relocate our equipment to the CDOT Yard in Glenwood Springs. Nate is working with CDOT and DOLA in coordination with Pitkin County to build and install cabinets in the CDOT yard in the mid-summer 2023 timeframe. Allowing NWCCOG to use this CDOT location is a testament to the closeness of our relationship with the CDOT ITS team. The costs for this relocation will be covered by Pitkin County and DOLA by repurposing one of their DOLA grant for the Roaring Fork Broadband Project.

The loss of Glenwood Springs has resulted in an adverse financial impact on the Project THOR program, however because Nate and Becky have worked hard with vendors and our Meet Me Center Hosts on cost reductions and improved budgeting to substantially reduce the future impact of Glenwood Springs departure from the program. Nate is also working on a stepped up ISP outreach strategy to bring additional revenues to the program.

Nate has begun conversation with Strata Networks to gain affordable access to a reliable network backup path to Salt Lake City. If the network loses Denver, all network traffic will still be able to connect to the internet in Salt Lake City. This is an item that is of growing importance to our Project THOR Stakeholders and ISPs.

Vintage – *Erin Fisher*, *Director*



Additional SB290 Funding Awards

In early 2022, Vintage submitted proposals on behalf of three community partners for funding through Senate Bill 290, aimed at supporting older Coloradans. Vintage was awarded \$166,350 for those providers. An additional funding opportunity was released under SB290, and Vintage recently was awarded an additional \$140,700 for internal programs and for Routt County Council on Aging. Details regarding the proposals:

Routt County Council on Aging: RCCOA's Helping Hands program provides non-medical home care and chore assistance to Routt County adults age 60+. The suggested fee is \$15/hour, but many clients cannot afford to pay even this nominal fee. The goal of the service is to provide Routt County clients assistance with daily activities and chores, so they can remain independent and safe in their homes for as long as possible. Services provided include "activities of daily living" such as home safety inspection, monitoring for falls while bathing or showering, medication reminders, assistance with meal preparation, light housekeeping (laundry, dishes, trash removal, snow removal), errands, shopping, doctors' visits, and companionship. Services not provided are medication management/administration, medical equipment service and administration, physical assistance with bathing, dressing, and large home repairs. Funding from SB-290 will make it possible to take the program to the next level by assuring its continuance for the 2022-2023 state fiscal year.

Vintage - SHIP Medicare Tracking Software: Through Vintage's SHIP Medicare Coordinator and her twelve highly-trained certified SHIP volunteers, the program collects beneficiary data that that is entered into two databases monthly. Currently, this client information is collected in paper form. The SHIP program will modernize the client intake process through a secure, online SHIP database software.

Vintage -DEI Consultants & Training

Vintage will take the buzz words "Diversity, Equity and Inclusion" (DEI) to the next level and hire DEI consultants to both audit Vintage and train and support their employees to build an innovative, future-ready culture that embraces diversity at every stage—both within the Area Agency on Aging and with their clients. Highlights include goal setting, creating an inclusive and affirming workplace and environment for clients, fostering equity, and building resilience.

Vintage - Hearing Aids

Vintage requested funding to diversify their current emergency material aid program to include hearing aids. The emergency material aid program is a contractual performance measure, and this grant grows the program to include financial assistance vouchers for hearing aids.

Vintage - Home Modification

Vintage requested funding to enhance their current Home Modification Pilot program. This program is a contractual performance measure and grows the program to serve more individuals in Grand County.

FY2023 Omnibus Appropriations Package

On Tuesday, December 20, 2022, Congress unveiled a highly anticipated \$1.7 trillion omnibus appropriations package to fund the Federal government for federal fiscal year 2023 (FY2023), which began on October 1, 2022, and ends September 30, 2023. Federal funding had previously been extended

by a series of continuing resolutions, or CRs, which level-funds the government at current amounts. The most recent CR was set to expire Friday December 23, 2022.

This chart focuses on the proposals contained within the FY2023 Final Budget deal. In the chart below, numbers in green indicate that enactment of these bills would increase funding compared to the FY2022 enacted levels.

Summary: The FY2023 omnibus package provides modest funding increases for aging & disability programs, includes a clear glidepath for Medicaid eligibility redeterminations, first-time funding for the aging network research center, and a substantial increase for OAA HDMs. However, the legislation also did not include other key priorities. The legislation did not reauthorize the EJA, provided only \$15 million for APS, and overall did not provide large increases in funding for OAA programs.

Planning Partnership Grant and CEDS Update

NWCCOG has applied for a new year of the EDD Planning Partnership grant. Rachel presented on details, including budget and scope of work. See packet for slides.

Quarterly Regional Economic Update

The Northwest Region has lower unemployment rate than the rest of the country. Average hourly earnings are still lower than both Colorado and the US, but there are several companies raising minimum wages within the region. Regional economies are still drive largely by accommodations and food service (26%). Healthcare, construction, administrative & waste services sector, professional & technical services sector have the highest wages. Construction, public administration, healthcare, and accommodation & food services are showing the largest growth across the region.

Macro-economic trends are downward: CCI, PSI, EI are all down, and inflation is high.

<u>Patti Clapper/Melanie Leaverton:</u> Giving employees a raise or bonus can put them out of earnings brackets to qualify for food, housing, etc assistance program. Farm bill helps with this.

Regional Data Coordination:

<u>Cory Mihm/Christina Oxley/DiAnn Butler</u>: Suggested working group on data. It would be beneficial for region to unify data.

Jon Stavney: Would like to see analysis and report of working group data.

Workforce Update

<u>Christina Oxley:</u> Hosting presentation on 10/31: "Where are all the Workers?". Focus will be on how to support employers in finding and retaining employees. She also noted that solving childcare and housing are also crucial to providing workforce.

<u>Rachel Tuyn:</u> Erin Young, CDLE "Employer Coach" will be presenting at the Dec 1 EDD meeting on this as well.

<u>Christina Oxley:</u> According to a study the "No one wants to work" has been a recurring theme since the late 1800's. This indicates that there might be more to be examined here on the employer side.

<u>Short term rentals:</u> A complete study of STR policies in the region would be beneficial. Many STR policies in our region are contingent on the midterm elections. Re: EDD Bylaw and Board Makeup Review

At the January 26, 2023 EDD Board meeting we will take some time to review the EDD bylaws, specifically on the section on board makeup. The EDA allows economic development districts the freedom to develop their board as they see most relevant and effective to each region, so long as board members represent the key economic development interests in the region. The NWCCOG EDD board is currently made up of representatives in the following categories: Counties; Municipalities; Economic Development Organizations, Stakeholder Organizations. The purpose of this review is to ensure the NWCCOG EDD bylaws accurately reflect the membership of NWCCOG and key economic interests. Current EDD bylaws as written are attached, as well as current EDD board member roster.

Things to consider during this review/discussion:

- How to address NWCCOG member communities outside of the NWCCOG EDD Boundary, specifically Routt County, Steamboat Springs, Hayden, Glenwood Springs. Routt County recently joined the NWCCOG region, however was not in the region when NWCCOG became an EDD. Thus, it is in NWCCOG Region, but not in "official" EDD boundary. This also applies to NWCCOG-member communities of Glenwood Springs, Steamboat Springs, and Hayden. Currently, we do have municipal representatives from Glenwood Springs and Steamboat Springs, but not Hayden. Currently we do not have a representative from Routt County. All these communities pay NWCCOG dues, which supports the EDD with match, and nothing precludes them from having a seat at the EDD table.
- Does the EDD board effectively represent the key economic interests of the NWCCOG EDD region? Are we missing anyone who should be at the table?

The EDD board will have a discussion at the 1/26/23 meeting, make suggested changes, and those changes will be incorporated into the bylaws for adoption by the board at the 3/23/23 EDD board meeting.

BYLAWS OF THE NORTHWEST COLORADO COUNCIL OF GOVERNMENTS ECONOMIC DEVELOPMENT DISTRICT

ARTICLE I Adoption and Effect

These Bylaws shall become effective upon the adoption thereof by a majority of the voting representatives of the Northwest Colorado Council of Governments Economic Development District (hereinafter, the "District" or "EDD Board") at any regular meeting, and shall not be construed to operate in contravention of any provision of the Articles of Association, Northwest Colorado Council of Governments/Economic Development District ("Articles of Association"). Any provision herein determined to be contrary to or in violation of the Articles of Association shall be null, void, and of no effect.

ARTICLE II Representation and Voting

1. Representation

The EDD Board shall consist of members that broadly represent the principal economic interests of the region.

- A. The EDD Board shall comprise the following representation:
 - One representative from each of NWCCOG's Member County Governments (Eagle, Grand, Jackson, Pitkin, Summit).
 - At least one representative from a municipality in each of NWCCOG Member Counties.
 - At least one representative from a municipality in one of NWCCOG's affiliated member municipalities outside Region 12 (i.e. Steamboat Springs, Carbondale, or Glenwood Springs).
 - One Economic Development Organization (EDO) Representative from each of NWCCOG's Member Counties (could be a Chamber of Commerce, Business Association, Visitor's Bureau, DMO, etc.).
 - One representative from Workforce.
 - One representative from Education.
- B. Each appointing authority may also appoint or elect one alternate for each representative it appoints or elects to the Board.

2. **EDD Board Officers.**

EDD Board officers shall be elected by majority vote of the representatives. Officers shall serve for a term of two (2) years from the date of their election.

- a. <u>Chairman</u>. The Chairman shall preside at all meetings of the EDD Board and shall be the chief officer of the EDD Board.
- b. <u>Vice Chairman</u>. The Vice Chairman shall exercise the functions of the Chairman in the Chairman's absence or incapacity.
- c. <u>Secretary-Treasurer</u>. The Secretary-Treasurer shall exercise the functions of the Vice Chairman in the absence or incapacity of the Vice Chairman and shall perform such other duties as may be consistent with the office of Secretary-Treasurer or as may be required by the Chairman.

3. **Term of Representation**

Each representative shall serve a two year term unless sooner replaced by the appointing authority. Representatives shall serve on the EDD Board at the will of the appointing authority. All representatives serving on the original EDD Board shall serve from the EDD Board's inception until the second January following the EDD Board's creation.

4. <u>Allocation of Voting Rights</u>

Each representative shall be entitled to vote on any matter that requires a vote by the Board. Each representative shall have a total of one vote. Only the representatives of those appointing authorities whose dues payments are current are entitled to cast a vote at a meeting of the EDD Board.

5. **Quorum**

A quorum shall consist of no less than seven representatives or their alternates. To pass a budget or set dues, the majority of the representatives comprising the quorum shall be government representatives.

6. **Telephone Polling**

In order to achieve a quorum, the EDD Board may poll by telephone, not more than two representatives, with respect to a specific matter before the EDD Board on motion or resolution. Such telephone polling shall constitute the equivalent of a physical presence at the meeting of the representative(s) so polled, shall be carried out by the Chairman, and the results of the poll reported to the EDD Board by the Chairman. The minutes for the meeting shall reflect that a telephone poll was taken, the results thereof, and the representative(s) polled by

telephone. Further, a memorandum of the telephone poll shall be approved and signed by the polled representative. If the representative(s) does not approve and sign the memorandum, the action upon which the vote, including the poll, was taken shall be null, void and of no effect.

7. <u>Electronic Voting</u>

With prior approval by the EDD Board, the representatives may vote via electronic means on subjects not related to the budget or the setting of dues.

ARTICLE III Annual Dues Assessment Policies

1. <u>Dues Assessment and Payment</u>

- a. The EDD Board will receive a dues payment from the Council equal to 50% of the EDD's adopted budget minus other revenues received or budgeted to be received.
- b. By August 31st, the EDD Board shall send notices stating the amount of the next calendar year's annual dues assessment. Confirmation of intention to pay the assessment is due to the EDD Board by October 31st. Dues assessments are due and payable on an annual basis by February 28th.

2. Required Withdrawal from EDD Board

In the event of non-payment of dues the EDD Board may by majority vote require that the non-paying entity withdraw its representation on the EDD Board.

ARTICLE IV Financial Management

1. Annual Budget

Each year between October 1 and October 15, the Chairman shall submit, by mail, to the EDD Board an estimate of the budget required for the operation of the EDD Board during the ensuing calendar year.

2. Funding Sources

The EDD Board is specifically empowered to contract or otherwise participate in and to accept grants, funds, gifts or services from any Federal, State or local government or its agencies or instrumentality thereof, and from private and civic sources, and to expend funds received therefrom, under provisions as may be required of and agreed to by the EDD Board, in connection with any program or purpose for which the EDD Board exists.

3. **Accounting**

The EDD Board shall arrange for a systematic and continuous record of its financial affairs and transactions and shall obtain an annual audit of its financial transactions and expenditures.

ARTICLE V Executive Staff

1. Hiring and Termination

The NWCCOG Executive Committee shall appoint professional Executive Staff who shall serve at the pleasure of the EDD Board, and may be hired and/ or terminated only by a vote of the Council pursuant to Article II Section 3 of the Amended and Restated Bylaws of the Northwest Colorado Council of Governments.

2. **Duties**

The Executive Staff shall serve as the general administrators of the EDD Board and shall oversee the daily affairs in a manner that carries out the will of the EDD Board, including but not limited to the following authority:

- a. The Executive Staff shall implement personnel policies, and shall hire, supervise and terminate employment for the staff of the EDD Board.
- b. The Executive Staff shall have the authority to enter into contracts for services and materials on behalf of the EDD Board provided, however, that the EDD Board has previously approved budget items encompassing such services and materials, and the contracts implement items in the Work Program approved by the EDD Board. In no event may the Executive Staff enter into contracts in excess of \$20,000. The Executive Staff shall have the authority to dispose of, by sale or exchange, property and equipment of the EDD Board up to and including a value of \$1,000 per unit or market lot, as appropriate, without prior approval of the EDD Board. Upon approval of the EDD Board or Executive Committee, as appropriate, the Executive Staff may dispose of EDD Board property or equipment valued in excess of \$1,000.
- c. The Executive Staff shall have the authority to bind the EDD Board during the course of contract negotiations with present or future contractors with the EDD Board provided, however, that the specific contract under negotiation has previously been approved by the EDD Board. The Executive Staff shall have the authority to implement change orders and contract amendments consistent with the intent and purpose of previously approved contracts.

ARTICLE VI Amendment

These Bylaws may be amended by resolution of the EDD Board, approved by majority vote of the EDD Board.

ARTICLE VII Rules of Order

Except as otherwise provided in these Articles, Robert's Rules of Order shall prevail for the conduct of business of the EDD Board.

ARTICLE VIII Meetings

The EDD Board shall hold meetings open to the public at least twice a year and shall also publish the date and agenda of such meetings sufficiently in advance to allow the public a reasonable time to prepare in order to participate effectively.

The EDD shall provide information sufficiently in advance of decisions to give the public adequate opportunity to review and react to proposals. The EDD shall communicate technical data and other material to the public so they may understand the impact of public programs, available options and alternative decisions.

The EDD shall make available to the public such audited statements, annual budgets and minutes of public meetings, as may be reasonably requested.

The EDD and its board of directors shall comply with all Federal and State financial assistance reporting requirements and the conflicts of interest provisions set forth in CFR § 302.17.

ARTICLE IX Committees

The EDD Board may establish advisory committees as may be necessary from time to time.

ARTICLE X Indemnification

The EDD Board shall indemnify, to the extent permitted by law, any person who is an officer, agent, fiduciary or employee of the EDD Board against any claim, liability or expense arising against or incurred by such person as a result of actions reasonably taken by him at the direction of the EDD Board. The EDD Board shall further have the authority to the full extent permitted by the law to indemnify its directors, officers, agents, fiduciaries and employees

against any claim, liability or expense arising against or incurred by them in all other circumstances and to maintain insurance providing such indemnification.
