Previously, Cook served as the president and CEO of University of Colorado Hospital (UCH), the only academic medical center in Colorado. Prior to UCH, Cook worked at UPMC (University of Pittsburgh Medical Center), serving as senior vice president of UPMC's Health Services Division, chief operating officer of Physician Services and president of UPMC Mercy. While at UPMC, Cook held several leadership roles, including vice president of operations at Magee Women's Hospital of UPMC, as well as vice president of transplant and ambulatory care at UPMC Presbyterian Shadyside. Cook's early career was spent with Johns Hopkins Health System where he held several positions including director of operations at Johns Hopkins International Medical Center in Singapore. Cook received a Master's degree in Health Administration from Washington University School of Medicine and a Bachelor of Arts degree in Business Administration from Texas A&M University. Cook enjoys spending time outdoors and exploring the Colorado landscape with his wife, Sarah, and two daughters, Sadie and Sofia.



# Dave Ressler, CEO, Aspen Valley Hospital,

As CEO of Aspen Valley Hospital Dave Ressler oversees an executive team that manages more than 400 employees. Dave has served two stints as the Hospital's CEO, first from 2004 to 2013, and from 2016 to present. He is responsible for ensuring the clinical excellence and operational success of the Hospital, and plays a key role in representing the organization to the public and the wider healthcare community. Dave has a bachelor of arts and an MBA, both in healthcare administration. He started in healthcare in the 1980s as an EMT, but has spent most of his career in healthcare administration in Aspen and two hospitals in southern Arizona. Dave is passionate about community healthcare and plays an active role in leading the industry's transformation to accountable care, assuring the entire community has access to high-quality care and the quality of life it affords. He helped found the Valley Health Alliance, a collaboration of local employers and healthcare providers that is working to improve healthcare outcomes and lower costs for residents and businesses from Aspen to Parachute. #### Jason Cleckler, CEO, Middle Park Health

Jason Cleckler, CEO, has been with Middle Park Health (MPH) since January of 2020. MPH is designated as a 25 bed Critical Access Hospital located in Grand County, Colorado. Middle Park Health boasts the first Level IV trauma center in the state and is one of the only critical access hospitals in the nation to be split between two locations. In addition they also operate six outpatient care clinics throughout Grand and Jackson Counties. Middle Park Health is also one of the largest employers in both counties with approximately 250 employees. Prior to his time with MPH, Cleckler was the CEO at Delta County Memorial Hospital in Delta, Colorado. In 2017 and 2018 he was named in the top 60/50 Rural CEOs in the Nation to Know from Becker's Review. Cleckler was also recognized by the American Hospital Association as the 2018 Colorado Grassroots Champion. This award recognizes hospital leaders "who most effectively educate elected officials on how major issues affect the hospital's vital role in the community, who have done an exemplary job in broadening the base of community support for the hospital and who are tireless advocates for hospitals and their patients." Cleckler's health care career began in the 1990's when he first became a Registered Nurse. During his career as an RN, he worked in a variety of capacities including Inpatient Psychiatry, ER/Trauma, ICU, and as a clinical instructor with the University of Colorado.



#### **Jonathon Godes, Regional Grants Navigator**

Jonathan has lived and worked in the mountain communities of the Western Slope building relationships, fostering collaborations, and working in, and with, local governments and the nonprofit community for the last 20 years.
