Valuation \$200,000 and up	\$3,500.00 plus \$10.00 for each \$1,000 or fraction thereof over \$200,000
Work performed without a Permit	Double the Permit Application Fee

\$375.00 each	Residential Permit Acceptance Failure
Double the Permit Application Fee	Work performed without a Permit
\$150 per conveyance	TCO Surcharge: issued per conveyance when a TCO is issued for the annual inspection
